

Privacy Notice

The purpose of this Privacy Notice is to provide information about data management to the visitors of the www.fux.hu website (hereafter: Website), which is operated by the FUX Ipari, Szolgáltató és Kereskedelmi Zártkörűen Működő Részvénytársaság (Address: 3527 Miskolc, Besenyői út 8., Tax Registration Number: 12477232-2-05, E-mail: fux@fux.hu; hereafter: Data Controller).

1. Data Management Purpose, Legal Basis and Methodology

The purpose of the Website is primarily informative, no direct sales or online administration can be accessed through it.

Visitors may contact the Data Controller voluntarily, by sending messages to the e-mail addresses displayed on the Website.

The Scope of Handled Data Includes:

- Name (if provided)
- E-mail address
- Phone number (if provided)
- The content of the message, as well as any other voluntarily provided data

Purpose of Data Management: Voluntarily provided data of visitors is managed exclusively for contact and administrative purposes and to answer inquiries.

Data Management Legal Basis: Voluntary consent of the data subject (Article 6 (1) (a) of the GDPR).

2. Duration of Data Management

The data provided during contact is handled for the maximum duration of 1 year, unless a contract is signed or business relations are established. In the latter cases, data is stored in accordance with the relevant legal requirements.

3. Data Processing, Data Transmission

The Data Controller does not transmit personal data towards third parties, nor do they engage in automated decision-making and profiling activities.



4. Handling of Website Visitation Data

In order to analyse the visitation of the Website, the Data Controller may also use the services of an external service provider (e.g.: Google Analytics). The service collects technical data (e.g.: IP address, date of visit, number of page downloads) anonymously, which is not suited for identification.
